



Dining Spend Asia Miles Lucky Draw Promotion ("Promotion") Terms and Conditions

- These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (each of which can be found in the Mox app and/or on our website) and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
- Without limiting clause 2 of these terms, these terms must also be read together with the Cathay Membership Account – Mox Registration Terms and Conditions ("Registration Terms") which can be found in the Mox app and/or our website.
- 4. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- Unless defined in these terms or the context requires otherwise, capitalised terms shall have the meanings given to them in our General Terms and Conditions.
- 6. During the Entry Period, if you:
 - (a) satisfy all of the requirements in clause 6 of the Asia Miles Local Dining Spend Promotion Terms or clause 6 of the Asia Miles Overseas Dining Spend Promotion Terms; and
 - (b) become eligible to receive the Reward under the Asia Miles Dining Spend Promotions in accordance with its terms and conditions.
